### **Course Description:**

This course introduces undergraduate students to the knowledge world of global and transnational sociology, in which it will offer a guided entry into the ideas of the sociological, anthropological, historical, political and legal scholars. The concepts they developed to analyze law, society and global governance are fundamental to address global and international concerns, including ESG (environmental, social & governance), SDGs (sustainable development goals), global climate change (Paris Agreement), global health (WHO), international economic, trade and monetary institutions (e.g., World Bank, WTO, IMF), global gender, children, labor and human rights systems, international justice, and international peace and security.

#### **Learning Outcome**

By the end of this course, students will be able to:

- 1. **Understand Global Order and Governance:** Grasp Chinese modernization in transnational world order, recognizing the key actors, institutions, and processes that shape global order and governance in the world society. (LO1)
- 2. **Apply ESG/SDGs:** Apply the Environmental, Social, and Governance (ESG) and Sustainable Development Goals (SDGs) in case studies, understanding their role in shaping policy and business practice for sustainable development. (LO2)
- 3. **Understand Carbon Neutrality Policy:** Grasp the carbon neutraly policy in Hong Kong and Mainland China, exploring their target, planning, and implications for local, national and global climate action. (LO3) And,
- 4. **Reflect on Personal and Social Responsibility:** Reflect on personal and social responsibilities in the context of global governance, considering implications and the role of individual action in achieving the SDGs. (LO4)
